Selected the Crop to be ensiled according to Livestock Production Manual. <ul style="list-style-type: none"> • Choose a high-quality crop with the right moisture content (typically 60-70%) for ensiling. If moisture content is high allowed to wilt for 6 hours. • Cleaned the chopping board • Cleaned the crop by removing debris, weeds, and other contaminants. 	3

4. Chopped the crop into small, uniform pieces (1-2 inches) to facilitate compaction according to Livestock Production Manual. <i>(Award 2 marks or 0 for cutting small sizes and 2 marks or 0 for cutting uniform pieces)</i>	4		
5. Filled the silage polybags as quickly as possible to minimize exposure to air according to Livestock Production Manual. <i>(Award 2 marks or 0 for filling and 2 marks for quick filling or 0)</i>	4		
6. Compacted manually to remove as much air as possible according to Livestock Production Manual. <i>(Award 4 marks or 0 for activity)</i>	4		
7. Filled the polybags to the recommended capacity to prevent overfilling as per livestock production manual. <i>(Award 3 marks or 0 for activity)</i>	3
